In this InvestorIntel interview with host Tracy Weslosky, [Valeo Pharma Inc.](#)'s (TSX: VPH | OTCQB: VPHIF) Founder, CEO and Director Steve Saviuk talks about closing a US\$40 million [non-dilutive financing](#) from Sagard Healthcare Partners and explains why Valeo is at "the right place at the right time with the right products."

Providing an update on Valeo's [licensing agreement](#) with Kaléo for the Canadian rights to ALLERJECT® he says, "We are relaunching it. Sales were \$4 million last year we expect sales to grow to about \$25 million." Steve also talks about adding ophthalmology as a new therapeutic focus for Valeo with [the acquisition](#) of the Canadian license rights to two innovative ophthalmic therapies from Novartis.
