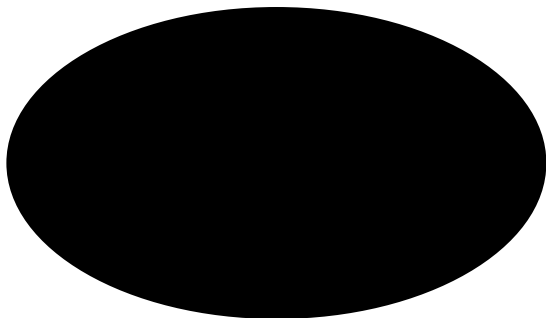


# eCobalt Announces Appointment of V.P. of Investor Relations and Idaho Cobalt Project Mine Controller
