**Frequently Asked Questions**

**1. If restrictions on physical gatherings are lifted, can I attend the AGM in person?**

No, all Shareholders and Proxyholders who wish to participate in the AGM must do so virtually via the Online Portal.

**2. What do I need to do before the day of the AGM?**

If you wish to participate in the AGM, please read the Online Meeting Guide (**Guide**) in advance. A copy of the Guide is attached.

Prior to the AGM, please check that you have a desktop or mobile/tablet device with internet access. You will also need to ensure that you have the latest version of your internet browser installed on the device you will use to attend the AGM.

**3. How do I register for the AGM?**

You must log into the Online Portal at <https://web.lumiagm.com/338978685> or via the "Lumi AGM" app available for download to your mobile device. For further details please refer to the Guide.

**4. I can't log into the Online Portal. What do I do?**

**5. What if I am disconnected from the Online Portal during the AGM?**

You can log back into the Online Portal using the steps outlined in the Guide.

Alternatively, please call the enquiry telephone numbers set out above.

**6. I don't have a (reliable) internet connection – what are my options?**

You will need to have a reliable internet connection to participate in the AGM via the AGM Online Portal.

If you do not have an internet connection, or are concerned about its reliability, we encourage you to submit your online vote or proxy appointment, as well as any questions you would like to ask, prior to the AGM.

Further details on how you can do this, including relevant deadlines, are set out in the relevant questions below/above.

**7. Can I participate in the AGM by telephone?**

No. The only way to participate is via the Online Portal.

**8. Can I vote prior to the AGM?**

No.

**9. Can I vote during to the AGM?**

Yes, you can vote during the AGM via the Online Portal.

Once you have logged into the Online Portal simply select your voting direction from the options shown on screen. The Chair will enable voting at the beginning of the meeting.

**10. Can I appoint a proxy to vote for me?**

You can appoint a proxy to vote on your behalf but must do so prior to the AGM. You can appoint a proxy either online or in writing using the Proxy Form. Refer to the Proxy Form for more detailed instructions.

To be effective, proxy appointments must be received by **10:30am (AWST) on 2 November 2020**.

**11. Can I ask questions prior to the AGM?**

Yes. You can ask questions prior to the AGM by completing the Shareholder Question Form and submitting it to [info@alkane.com.au](mailto:info@alkane.com.au).

**12. Can I ask questions during to the AGM?**

Yes, you can ask questions during the AGM via the Online Portal.

**13. Can others see me if I participate in the AGM via the Online Portal?**

No.

**14. What if I lose connection with the Online Portal and miss my opportunity to ask a question or vote?**

You will need to be logged in to the Online Portal in order to ask questions and vote at the AGM. If you lose connection with the Online Portal you may miss your opportunity to vote or ask a question.

**15. When will voting be closed?**

Online voting will remain open for 10 minutes after the close of the meeting.

**16. How do I watch a recording after the AGM?**

A link which will allow you to watch a recording of the AGM will be posted on the Alkane website (<https://www.alkane.com.au/agm>) shortly after the AGM.

## Attending the AGM electronically

To participate online, you will be able to view a live webcast of the meeting, ask questions and submit your votes in real time. To access the meeting either

## CREDENTIALS

Once you have navigated to the meeting, via either the app or web page.

You will then be required to enter your:

- Postcode.

Or, if you have been appointed as a proxy, you will need to obtain your login credentials from the registrar by calling +61 8 9389 8033

## ACCESS

To register as a shareholder, select '**I am a shareholder/proxy**' and enter your username and password.

As a guest, you will be prompted to complete all the relevant fields including, first name, last name and email address.

## NAVIGATION


When successfully authenticated, the info screen  will be displayed. You can view company information, ask questions and watch the webcast.

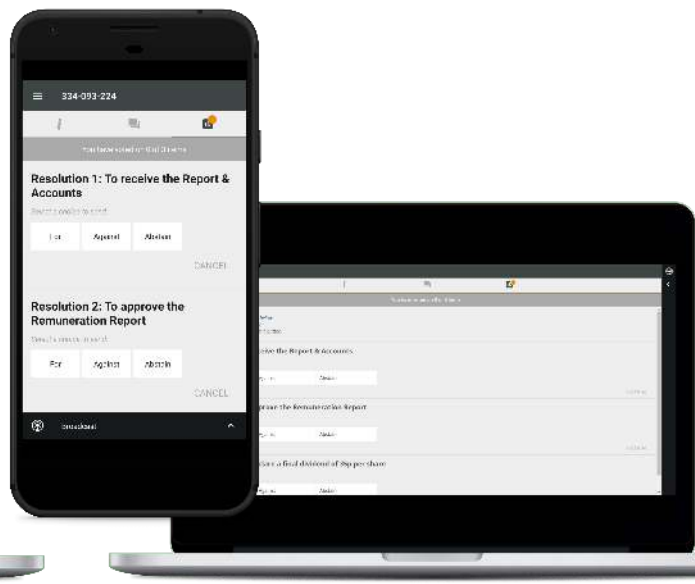
If you would like to watch the **webcast** press the broadcast icon  at the bottom of the screen.

## VOTING

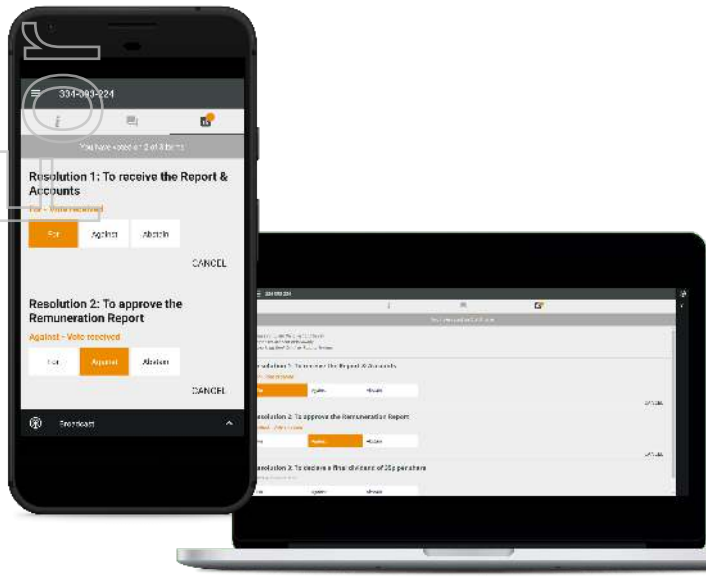


## VOTING

To change your vote, simply select another direction.

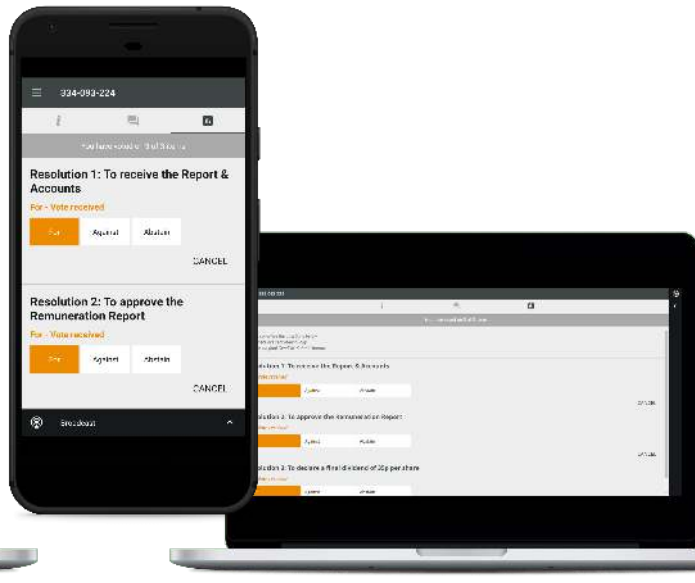
If you wish to cancel your vote, please press Cancel.

If you would like to ask a question, select the messaging icon 

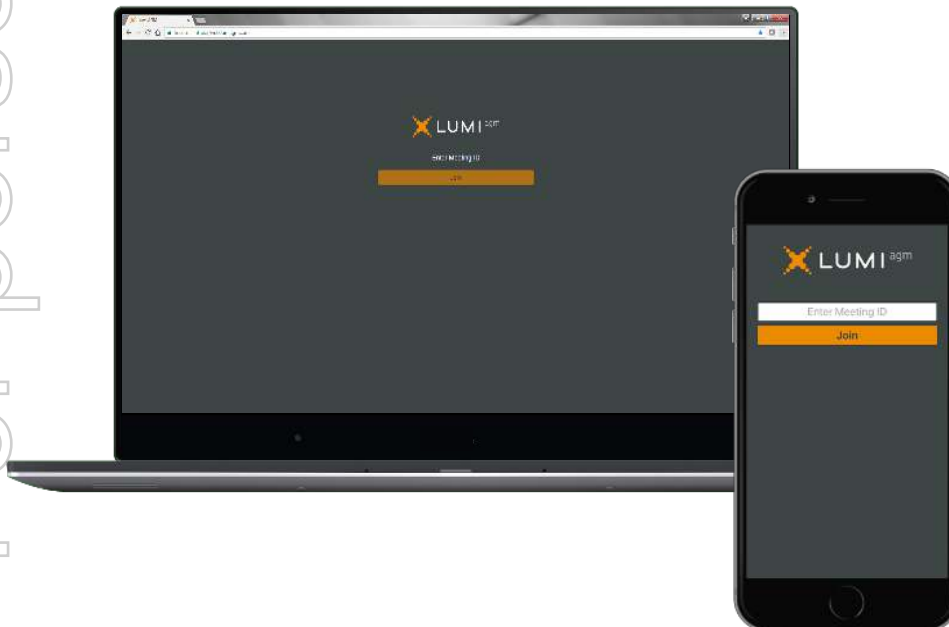
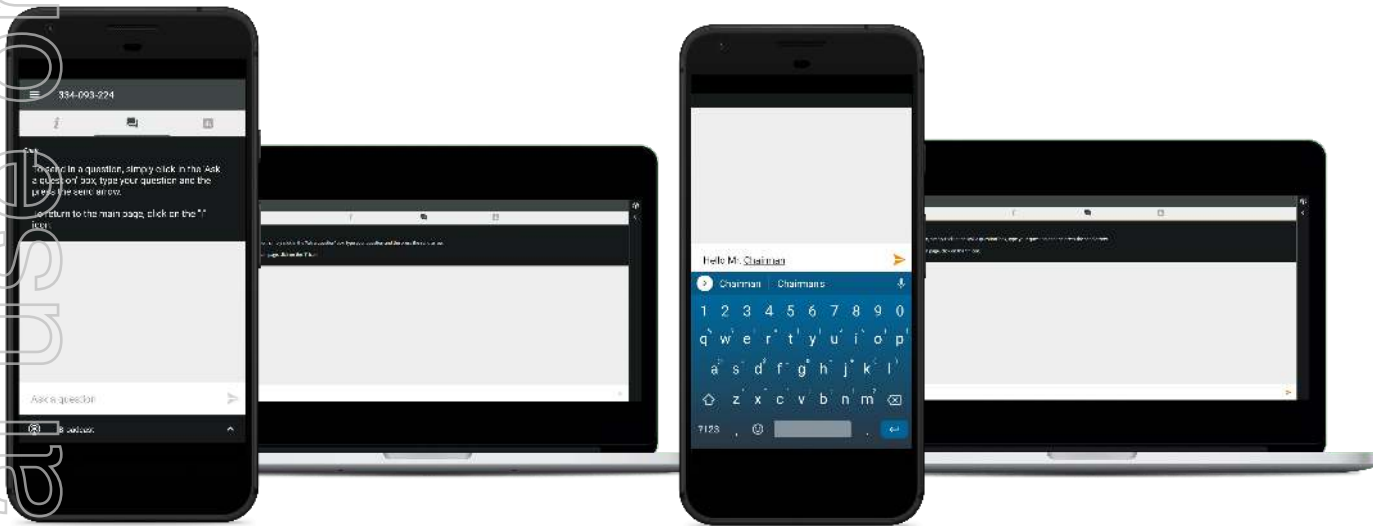
Messages can be submitted at any time during the Q&A session up until the Chairman closes the session.

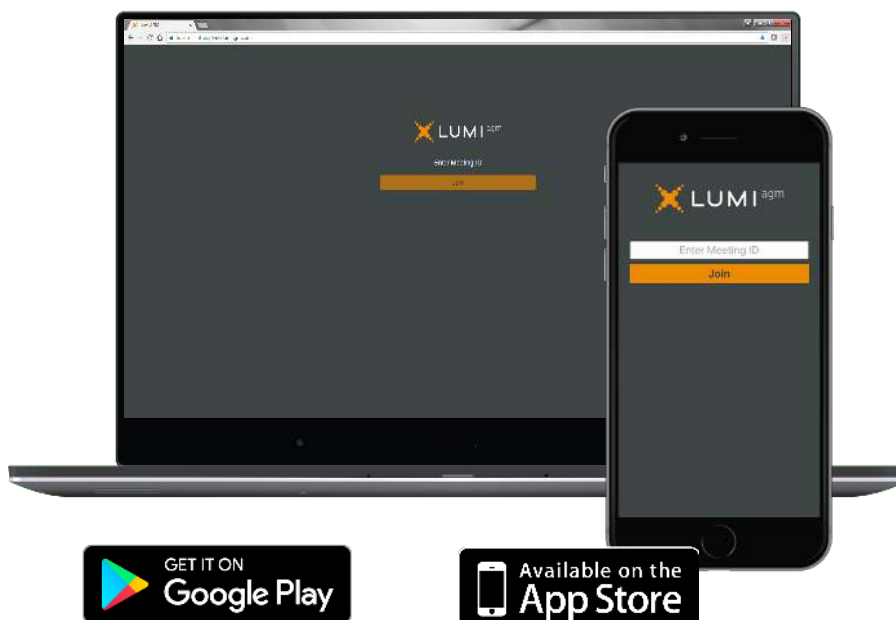
